



Attorney Continuing Legal Education Certification

CLE REQUIREMENTS: Every active lawyer in the Commonwealth of the Northern Mariana Islands (CNMI) shall complete **TWENTY (20) HOURS OF CONTINUING LEGAL EDUCATION (CLE)** for **TWO (2)** calendar years. Attorneys may carry over a maximum of ten (10) CLE credit hours to the next reporting period. The reporting period for lawyers who are not active for the entire compliance period is prorated based on the month of admission. Attorneys who are admitted after July 1, 2002, shall attend and complete a course in Professionalism sponsored jointly by the CNMI Supreme Court and the CNMI Bar Association during their term of admission.

REPORTING CLE CREDIT: CLE credits shall be reported to the CNMI Bar Association every other year, in the even-numbered years on or before February 15. The two-calendar year period (January 1 to December 31) immediately preceding the even year is the reporting period. The next deadline to submit certification compliance with CLE credit requirements is **February 15, 2024**. CLE reports must be submitted to the CNMI Bar Association.
